- For persons born on/after 1/1/90
- For 3-wheel ATVs
- For ATVs over 90cc; (MN: 110cc)
- For all ages; under age 18 must complete safety course
- Sale to under age 16 prohibited Sale of ATV over 90cc for use under age 16 prohibited
- For persons born after date specified in
- Unless equipped with windshield/screen Provisions exclude ATVs engaged in farming, hunting or trapping. In SC, also exclude supervised operators younger

than 16, but not younger than 6, on

- private lands.
 Except for operators 16 or older on ocean beach areas open to ATVs or operators
